- GNP growth slowed. How relevant is that for consumption and demand?

- How stable are Brazil's democratic institutions?
- The Euro > Real exchange rate increased 30%: Is that bad for Dutch exports, or for good local production opportunities?
- How will Dutch Trade and Investments be affected by the recent classification of The Netherlands as "preferred tax regime" by the Brazilian authorities, and what measures are now required?
- How will the off-shore industry and exploration projects withstand low oil prices?
- The Olympics will boost tourism, but can that be affected by the new "Zyca" virus?
- What threats and opportunities may result from environmental problems, such as shortage on drink water supplies, or the mining disaster affecting the Rio Doce river?
- All in all, in which sectors is this a time to be cautious, to "wait and see", or to act and invest?

Dutcham is once more bringing specialist speakers to discuss these topics in an open and interactive setting, seeking to analyze the best and worst case scenarios.
